<b>The Allen Lane Foundation</b>	<p>The Allen Lane Foundation aims to fund small registered charities, voluntary groups and charitable organisations that support causes which they believe to be unpopular – both in society and with other funders. They focus their work with adult, and the areas within this include:</p> <ul style="list-style-type: none"> <li>• <b>Asylum seekers or refugees</b></li> <li>• <b>Gypsies and Travellers</b></li> <li>• <b>Offenders and ex-offenders</b></li> <li>• <b>Older people</b></li> <li>• <b>People experiencing mental health problems</b></li> <li>• <b>People experiencing violence or abuse</b></li> </ul> <p>They want to help organisations to become sustainable through supporting running and core costs – enabling flexibility, security and longevity. The work of organisations must include a significant proportion of people from one or more of these eight groups – as it is more likely that your application will be successful. The maximum grant size is <b>£15,000</b>, with the average grant size being <b>£5,000-£6,000</b>. They believe every young person should have the opportunity to travel to a new place and discover new environments away from home with their friends. Breaks for Kids can contribute up to 50% of the cost of accommodation and meals for young people from low-income households on trips with schools, community groups and charities or other youth groups.
